It's the final countdown...
With only two full days of election campaigning left, the political noise has reached fever pitch. Clearly the events in both Manchester and London are rightly dominant in both politicians and the general public's mind, however, the issue of social care remains prominent in the news. As we move into these final stages, there will be limited further detail of any policy area revealed, as the increasing influence of sound bite politics takes hold. The key will now be to see what happens in the immediate aftermath of the election and how to keep a strong and sustained focus on social care, and addressing the longer term issues around funding, impact of Brexit, workforce challenges, technological change and integration – amongst others... The high profile attention to social care from all parties does not feel like this is an issue that can be put back in the box post-election – and NCF and our colleagues across the sector will be working hard to quantify the political commitment in the following weeks.

Before we leave the issue of the election, we want to make one final push around [apromotehevote](#). I know that many of you will have been active in supporting those you provide care and support to, in registering to vote. However, it is critically important that this week you also support them to use that vote.
